The Culver LakeFest Committee welcomes you! Please take a moment to read the following rules and regulations before submitting your application to ensure a successful event for everyone involved.

*There will be a limited number of commercial applicants accepted. The Lake Fest Committee is looking for those commercial items of quality and uniqueness.

*Only the items listed on the application and approved by the committee may be exhibited.

*The Lake Fest Committee reserves the right to reject unsuitable exhibits and may ask an exhibitor to immediately remove the unsuitable items.

*Please NO items of vulgar or inappropriate material for children: i.e. sex, nudity, alcohol, guns, etc. Those items deemed vulgar or inappropriate will be asked to be removed for the rest of the festival.

*At all times during the festival and setup please be mindful of others and wear appropriate attire – i.e. shirt, shoes, pants, etc.

***A photograph of your item/items must accompany your application.** Please enclose a SASE if you wish your photographs returned. Please put your name on the back of the photos.

***Applications must be received by June 1, 2017. A \$25 late fee will be applied to those received after June 1, 2017.**

****All exhibitors must supply their own table, chairs, tent or covering, and an extension cord at least 150 feet in length rated at least 20amp 110volts.*** The festival will be held rain or shine. Space is limited.

*All displays, equipment, and merchandise must not present a hazard to the public. The Lake Fest Committee reserves the right to reject anything.

*Lake Fest hours as follows – All times are EST:

Friday: July 14th 4pm – 10pm

Saturday: July 15th 9am – 11pm

Sunday: July 16th 9am - 3pm

****Setup begins at 8am est and no later than 12pm est***

****No booth or display may be removed from the park prior to Sunday, July 16th at 3pm.***

*The Culver Lake Fest Committee will provide general security after hours of the festival. The Lake Fest Committee is not/will not be held responsible for lost, stolen, or damages items, equipment, etc. The Lake Fest Committee is not/will not be responsible for accidents.

*Booth space is approximately 12' x 12'. ***Electricity is provided at 110volts 20amps, one outlet per space.*** Spaces will be assigned in late June, early July. Sharing, trading or selling of spaces is strictly forbidden without the approval of the Culver Lake Fest Committee. NO EXCEPTIONS.

***There will be absolutely no overnight sleeping in the park.**
